Dear Representatives Bilirakis, Murphy, Cardenas, and Davis:

On behalf of the undersigned organizations, a coalition of national medical societies, representing a broad range of physicians, health professionals and practice managers who care for Medicare beneficiaries in a community-based, office setting, **thank you for introducing H.R. 3674**, **the "Providing Relief and Stability for Medicare Patients Act of 2023."** This critical legislation mitigates cuts to office-based specialists for a targeted group of services for two years, thereby helping to avoid significant disruptions in patient access to care while overall concerns regarding the future of Medicare physician payments are addressed.

Office-based specialty care is a critical service outside of the hospital setting. These specialists provide a wide range of services to patients with cancer, end-stage renal disease, eye disease, fibroids, as well as limb salvage and venous ulcer needs. The office setting is also critical for patient access (especially in rural and underserved areas) and can result in patients receiving care in a timelier manner. Unfortunately, the prolonged instability within the Medicare Physician Fee Schedule (PFS)—driven by a confluence of fiscal uncertainties physician practices face related to statutory payment cuts, perennial lack of inflationary updates, significant administrative barriers, and the cumulative impact of the pandemic—is jeopardizing the financial viability of many community, office-based, physician practices.

H.R. 3674 would provide targeted relief for these practices by providing an increase to the non-facility practice expense relative value units (PE RVU's) for those procedures performed in an office-based setting that utilize high-tech medical devices and/or equipment and thus were most negatively impacted in the 2022 PFS with the updating of the clinical labor costs in the budget neutral practice expense methodology.

As you are aware, the discrepancy between what it costs to run a physician practice and actual payment combined with the administrative and financial burden of participating in Medicare is incentivizing market consolidation. We are concerned that the ongoing severity of these cuts, combined with additional payment adjustments anticipated in the forthcoming CY2024 PFS, will result in a breaking point for many physicians. **Absent additional Congressional intervention via passage of H.R. 3674**, the result will be more providers leaving the field (either through retirement or career adjustment), more practices being closed or sold, and a significant number of patients losing access to a variety of healthcare service in their communities.

Again, thank you for your efforts and leadership in introducing legislation to provide targeted relief for community-based physician practices. Our organizations stand in strong support of H.R. 3674 and look forward to working with you to advance this critical bill.
