

Continuum of Care for Non-resectable NSCLC · Presenters' Disclosures of Relationships

The American Society for Radiation Oncology (ASTRO) is an Accreditation Council for Continuing Medical Education (ACCME)-accredited CME provider and complies with the ACCME Standards for Commercial Support. Employment = positions held at the time of disclosure. These include both full- and part-time relationships, whether compensated or uncompensated.

Compensation/Remuneration/Funding = includes consultant/advisory roles, honoraria, research funding, travel expenses, in-kind donation, etc. If a committee member receives an honorarium and donates it to charity, the honorarium is disclosed. If a presenter declines an honorarium and it is paid directly to charity, the honorarium is not included. Honoraria from accredited CME providers are not included.

Ownership or Investment Interests = includes stock, stock options, partnership, royalties or patents. Stocks in mutual funds, blind trusts or other holdings that are not controlled by the individual or an immediate family member are not included.

Leadership Positions = positions held in other organizations or entities.
